# Patch Management:

**File Servers:** noncritical and severe patches are being scanned and applied every Friday at 8 PM, after review

**Desktops:** noncritical and severe patches are being scanned and applied daily between 7 and 10 PM, after review

\*\*critical and severe level patches and definition updates are being applied at high priority review

<u>BDR servers:</u> Approved by finance committee, awaiting payment. Order is already prepared. Once the order is placed, we will begin installing the backup agents onto the servers prior to the BDR servers arriving.

**Security:** Systems appear stable. No recent spyware or malware infections detected.

- 1) Renewal of antivirus, upgrade to PC's and servers.
- 2) Installation of online backup per approval from the finance committee. Work with depts. to determine where they will be installed.
- Completion of IC Highway network monitoring this week. Further review of this network to follow.
- 4) Currently reviewing network traffic flow to optimize Internet bandwidth.
- 5) Suggest replacement of network switch and firewall for IC Land Conservation and IC Highway.
- 6) Update firewall's to Comprehensive Gateway Protection
