Minutes of Sept 14, 2010 at 10:00am Iron County Board Room

Meeting called to order by Interim Chair Bob Traczyk, Register of Deeds at 10:00 a.m. All members present except Opal Roberts who is the Town Clerk and today is election day.

Bob Traczyk certified that the meeting was properly posted in the Daily Globe, on the radio and on the county website-www.co.iron.wi.gov

Bob gave a brief history of how the Land Information program was started and how the funding began using an increase in recording documents in the register of deeds office as the source of revenue and that is still carried on today.

Bob called for nominations for chair of the new committee, since as former chair he filled in as temporary until someone was nominated. Bob has announced his possible retirement at the end of his term and declined to chair the new committee. Tom Bergman expressed an interest and so Kathy Tutt nominated Tom Bergman as the Chairperson and that was seconded by Clara Maki. There being no further nominations; the nominations were closed and Traczyk called for the vote and all voted in the affirmative.

Bob Traczyk volunteered to be the secretary since he has all the files and minutes from the former Land Information Committee. The committee accepted his offer.

The committee looked briefly at the 5 year plan from 2005 to 2010 and will begin work on the 2010-2015 Five year plan immediately. The deadline is October 1, 2010. We will see how far we get on the new plan and if we are not able to complete it, then ask the Dept of Administration for an extension. Bob mentioned that during anytime the committee can amend the 5 year plan and submit the amended plan to the Dept of Administration for approval.

The following projects have been the top priorities for the past 5 years:

The GIS parcel maps need to be updated and published on the county server.

The treasurer's office will proceed with a plan to get the tax roll information online
