Committee discussed the differences between the Bibeau and Heil Dump Box. The Bibeau box has a heavier strength rating. Burke hitch has bushings and shock absorbers that will be easier on the truck. The box is enclosed with stainless posts. Burke Truck will be leaving a plow here for our use in case of an emergency. Truck will be going on Hwy 47/182 state beat. Stainless & Repair has been in business for 36yrs and has a 3yr normal wear and tear warranty, 5yrs paint per Gary Witt.

Motioned by Innes, supported by Koski to award the equipment bid to Stainless & Repair. Motion carried.

Paving CTH H Project – Northwood's Paving remilled the area and repaved. The ride is still not any better than before it was milled. Commissioner spoke with Morzenti on the issue.

Radio Tower – The communication on the south end of the county is limited. Estimate for installing a repeater is about \$9,753. May have to run a two-channel system and we want to keep it a one channel. Commissioner meeting with Elcom on Thursday.

Budget: \$16,989 Estimated year-end balance. DeRosso authorized paying for the truck and equipment the first of January. Motioned by Koski, supported by Lambert to accept the cash flow report. Motion carried.

 - o Mercer bus driver would like to see the county roads plowed earlier. We have a 4" minimum call out policy that will be followed. Won't be called out any earlier than 4:00A.M, due to budgeting.

Winter Highway Conference is scheduled for January 10-12, 2011 at the Kalahari Resort in Wisconsin Dells. Kichak and Nelson will be attending and staying for the banquet.

Motioned by Lambert, supported by Youngs to approve payment of the bills for October \$48,856.98. Motion carried.
