Discussion took place about the positive feedback received at the Gogebic County Fair and the Iron County Fair.

A question was raised as to what time Board Members should be present at the Fly-In/Airport Day to volunteer.

Mr. Harma stated that the pancake breakfast will begin at 7:30 A.M. and the Fly-In/Airport Day will conclude at 3:00 P.M.

The layout and number of crafters was discussed.

Ms. Scorse confirmed that Mr. Bob Cannon would be present at the Fly-In/Airport Day to sing the Nation Anthem during the welcoming ceremony.

Mr. Nasi confirmed that Mr. Joe Bonovetz will be setting up a PA system which is being borrowed from the Cornerstone Church.

The location of the welcoming ceremony was discussed.

Discussion took place regarding having an open house at the airlines terminal building. It was decided that due to lack of volunteers/staff, there would be no open house.

Ms. Scorse listed the different events and attractions the health department and Aspirus Grand View hospital would be presenting. *Ms. Scorse also stated that 50/50 raffle tickets would not be sold at this year's Fly-In.*

The EAA Young Eagles program was discussed. Mr. Harma said there will be at least two airplanes offering the free flights through the Young Eagles program.

A brief discussion took place concerning the price of airline tickets and where tickets can be purchased at the lowest price. Advertisement for the Fly-In/Airport Day was discussed. Mr. Harma does not want to spend more than \$500.00 on advertisement (for the Fly-In/Airport Day).

The Committee agreed to ask Mr. LeRoy Kangas if it would be possible to use the picnic tables from the fairgrounds for this year's Fly-In/Airport Day.

An open house at the airlines terminal building was discussed again.

Mr. Berg volunteered to spend the day at the terminal building with his wife so there could be an open house; he also suggested asking Mr. Kangas and his wife to volunteer for this.
