## IRON COUNTY EXTENSION EDUCATION COMMITTEE MEETING Iron County Courthouse – County Board Room – Hurley, Wisconsin Tuesday, May 13, 2014 – 4:00 p.m.

Call to Order: Meeting called to order at 4:00 p.m. by Office Manager, Joyce Gayan.

**Roll Call and Introductions:** Roll call was taken by Gayan. Committee members present: William Thomas, Paul Mullard, Karl Krall, and Brad Matson. Committee member excused: Opal Roberts. Also in attendance: Gayan, Will Andresen, Andrea Newby, Neil Klemme, Deb Leonard, Joy Schelble, Amy Nosal, and Iron County Board Chair, Joseph Pinardi. Extension staff and Committee members introduced themselves.

Acknowledge proper meeting posting: Gayan acknowledged proper meeting posting.

Approval of agenda as posted: Thomas moved to approve agenda as posted, seconded by Mullard. All in favor.

## **Committee Reorganization:**

- a) Election of Chair Gayan entertained nominations for position of Committee Chair. Matson nominated Thomas, seconded by Mullard. Gayan called three times for any other nominations. No other nominations were made. Matson moved to close nominations and cast a unanimous ballot for Thomas, seconded by Mullard. All in favor.

No other nominations were made. Matson moved to close nominations and cast a unanimous ballot for Roberts, seconded by Mullard. All in favor.

**Public Comment:** Matson stated that he would like to bring Sherman and Hurley closer together by informing the residents of Sherman of programs available to them. He asked that UW-Extension keep that in mind when promoting programs.

Authorization for 4-H Youth Development Agent travel: Klemme reported that he was selected to go to Ghana, Africa for three weeks in June to educate adults to work with young people in their 4-H program. The travel will be funded by UW-Extension. Mullard moved to support 4-H Youth Development Agent's travel to Ghana, seconded by Matson. All in favor.

**Horticulture Assistant Report** – Schelble reported on her horticulture work and how it works in conjunction with nutrition education. She discussed:

- Bugs and weed identification
- Answering horticulture related questions
- Monthly class at Mercer Library in conjunction with new seed library
- Outreach with horticulture publications
- Distribution of seeds donated by Burpee Seed Company
