**Manager's Report**

Mr. Harma told the Airport Board that the Land Pride rotary mower was delivered to the airport today. Mr. Harma briefly discussed topics that were discussed at the conference he attended earlier in the week. A brief discussion took place regarding fuel vendors and a fuel truck. Mr. Harma spoke about the taxiway project that will begin later this summer. The last topic Mr. Harma discussed was Airport Day; he said the airport will be borrowing some tables from the Iron County Courthouse but more tables are still needed for Airport Day. Mr. Mullard suggested that Mr. Harma contact the VFW in Hurley.
