Youngs called meeting to order at 4:00 P.M.

Roll call was taken Kichak absent.

The meeting was properly posted in the Iron County Miner, Ironwood Daily Globe and announced on WJMS and WUPM.

Motioned by Thompson, supported by Hanson, to approve the minutes from the meeting on September 19, 2017. Motion carried.

Appearance of Anna Wisner, WisDot – Committee signed 2018 Routine Maintenance Agreement (RMA) \$1,108.000. Budget was exactly the same as 2017; fund allocations changed.

Wisner thanked commissioner for completing and assisting with the following projects:

- Hwy 122 1.5 miles resurfaced
- Hwy 77 Culvert liners
- Vilas County Culvert liners
- Hwy 51 Culverts, storm damage
- Hwy 169 Installed 4 culverts; 5 culverts Hwy 122
- Hwy 182 Crack sealing

Appearance of Norman Barrientos to discuss constructing a new Mercer Shop Facility. Presented concepts from other counties that Barrientos designed. Garages included Polk, Calumet, Jefferson, Manitowoc, Door, Sun Prairie, Menominee, Gogebic and Fond Du Lac Counties. Barrientos would contract with Ayres Associates or a subconsultant for stormwater, right-of-way and town issues.

Design will be in three phases:

- Task 1 Space Needs; Review operations, tabulate square footage, review shop, parts, storage and office activities. Create rough cost estimate for the building and site based on the space needs data.
- Task 2 Existing Building & Site Reuse Evaluation. Develop rough scale of costs for renovating the existing garage into cold storage.

• Task 3 – Concept Building and Site Planning. Gather information on the new site from publicly available maps. Prepare report of study, recommendations and cost estimate. Lump sum fee \$12,483. Total time for Concept Design is eight weeks.

Motioned by Thompson, supported by Erickson, to move forward with designing a facility for the Mercer Shop using Barrientos Design and Consulting. Motion carried.

Tim from Dean Law Office created an Overweight Permit for Michigan logging truck loads on county roads. No surrounding counties or towns have an Overweight Permit implemented. Motioned by Thompson, supported by Hanson, to charge \$25/permit fee for each truck. This will be an annual fee. Permits will be void during Weight Restrictions and areas that are posted. Motion Carried. Approved permits will be emailed to DMV/WisDot.

- CTH A Bridge will be a local let project. We will pay all the invoices and be reimbursed. An intern loan may be needed.
