

The Iron County Comprehensive Planning/Land & Zoning Committee met in the Board Room of the Iron County Courthouse in the City of Hurley, WI on Tuesday, August 18, 2020. The meeting was called to order by Chairman Pat Hanson at 3:00 p.m. Proper publication of the hearing was established. Committee members present were Chairman Pat Hanson, Anne McComas, John Sendra, and Thomas Thompson, Jr. Also present was Administrator Erika Roeder, County Chairman Joe Pinardi, and Todd Maki of Maki Land Surveying.

Motion to approve minutes from the 7/21/2020 meeting by Thompson/Sendra; carried 4-0.

Bear Tracks Lodge LLC (Scott & Krystal Kurinsky) Conditional Use Hearing: Allow the operation of a tourist rooming house in an RR-1 (Residential Recreation) zoned district located in part of GV Lot 1, Lot 3 of the Tamarack Subdivision, Section 18, Township 41 North, Range 3 East, Town of Sherman (site address is 4582W French Lake Road). Postponed at previous meeting. No Town approval received. Discussion then motion to postpone by McComas/Sendra; carried 4-0.

Heady Properties, LLC Conditional Use Hearing: Allow the construction of a 5000 sq. ft. accessory building in an RR-1 (Residential Recreation) zoned district located in part of Lot 2 of CSM #192, Section 33, Township 42 North, Range 2 East, Town of Mercer (site address is 2890N Shady Rest Road). Hanson opened public comment. None received, public comment closed. Postponed at previous meeting. No Town approval received. Discussion then motion to postpone by Sendra/Thompson; carried 4-0.

Geof & Lynn Bednar Conditional Use Hearing: Allow the construction of a 1200 square foot accessory building in an RR-1 (Residential-Recreation) zoned District located in part of Lot 3 of CSM #476, Section 9, Township 43 North, Range 3 East, Town of Mercer (site address is 4495N Popko Circle). Hanson opened public comment. None received, Hanson closed public comment. No Town approval received. Discussion then motion to postpone by Sendra/Thompson; carried 4-0.

Scott Sanborn Conditional Use Hearing: Allow the construction of a 3120 square foot accessory building in an RR-1 (Residential-Recreation) zoned District located in part of GV Lot 1, Section 1, Township 42 North, Range 2 East, Town of Mercer (site address is 4994W County Road FF). Hanson opened public comment. None received, Hanson closed public comment. No Town approval received. Discussion then motion to postpone by Sendra/Thompson; carried 4-0.

Jeff Baxter 2 – Lot CSM: Review a 2 Lot CSM by Maki Land Surveying, LLC, covering part of the SW ¼ of the SW ¼, Section 7, Township 42 North, Range 3 East, Town of Mercer. Site address is Turtle Road and Popko Circle West. Roeder stated it met requirements. Discussion then motion to approve by Pinardi/Thompson; carried 4-0.

Red Pine Plaza 3 – Lot CSM: Review a 3 Lot CSM by Maki Land Surveying, LLC, covering part of the SE ¼ of the NW ¼, Section 18, Township 43 North, Range 4 East, Town of Mercer. Site address is County Road H. Roeder stated it met requirements. Discussion then motion to approve by McComas/Sendra; carried 4-0.

Patrick Neubauer 2 – Lot CSM: Review a 2 Lot CSM by Coleman Engineering Company, covering part of Lot 1 & 2 of CSM #508 and Lot 1 of CSM #91, Section 2, Township 43 North, Range 4 East, Town of Mercer. Site address is County Highway H. Roeder stated it met requirements. Motion to approve by McComas/Sendra; carried 4-0.

Discuss CWD Committee: Discussion of the former CWD Study Committee and their efforts in the kiosk and dumpster programs. Discussion of the Land Use Ordinance and Conditional Use before the moratorium runs out. Some members of the former CWD Study Committee are now members of the CWD Task Force working in cooperation with the Wisconsin Department of Natural resources.

Administrators Report: Roeder stated that call volume and customer service requests have been quite brisk and permit numbers are on par. Work continues with the Ordinance revisions. The Saxon Harbor LOMR is in FEMA's hands.
