County requesting \$225,000 from Highway Department. Motioned by Erickson, supported by Krall, to reallocate \$225,000 to balance the county budget. Motion carried. Discussed borrowing money if the chipper needs a major repair. CTH G has no grant funding for the 2025 project, may have to cut back the length of the project.

Commissioner Report:

• Meeting with Jon Simonson, DNR on May 14th regarding the 2023 CTH FF project. Concerns with the shoulder gravel that was used. Permit states 6" minus fracture rock, we used screened round rock. May cost \$50,000 - 75,000 if material must be excavated. The closest rock is Forestry rock in Hoyt Pit.

• Invited to a John Deere factory tour in Debuque, Iowa in May or June. The Commissioner will attend using his own time, will have 2 employees attend. John Deere covering the motel, transportation and meal expenses. Motioned by Erickson, supported by Tanner, to grant request and attend the tour. Motion carried.

Reviewed 2024 Budget - Motioned by Erickson, supported by Tanner, to approve budget. Motion carried.

Motioned by Erickson, supported by Tanner, to approve payment of April bills \$20,822.09. Motion carried.
