DNR Report: Katy reported the team time standard hours are currently at 1451 hours (58%). An LTE Forester Technician has been hired. He will be working on the Iron County and Ashland County Forests. The team as attended preseason fire training and meetings as well as working on timber sales.

Forestry Committee Meeting - March 12, 2025

2025 YTD Timber Sale Receipts -- \$301,391.59 vs. \$400,220.20 in 2024 Difference - \$98,828.61 (24.7%)

Forestry Activity

- 5 Logging Crews working on ICF.
- 12 active sales (hauling, closeouts, etc.)
- Spring road restrictions were put in place March 10th, halting most logging operations.
- 13 16 timber sales planned for spring bid offering.
- 3rd carbon credit sale was recorded in late February.
- After expenses and Anew's share Iron Co. will receive \$198,400.00.
- Video marketing project is not yet completed.
- Anew is awaiting guidance from ACR on conversion to 2.1 protocol for RP2 and RP3 credits.

County Parks

- Saxon Harbor has 2 24' and 1 28' slips available for 2025 season.
- 3 people have not yet returned deposits.
- Campground reservations continue to fill for this summer.
- Advertising for a summer intern for park mowing and light maintenance.

County Forest Roads

Wildlife Openings

Foresters are frost seeding winter logging roads and landings.

Recreation

- Officially closed snowmobile trails for the season on March 9th.
- Trail closed briefly in late February due to abnormally warm weather and low snow conditions.
- 20" of snow allowed for reopening and 1 last good weekend before closing.
- ATV trails will reopen when conditions improve and dry. Typically mid-May.
- ICF crew completed bridge construction for Hurd Creek Bridge ATV project.

Miscellaneous

- Participated in WCFA Administrator's Quarterly Conference Call.
- Participated in WCFA Legislative / Certification Committee meeting in Merrill.
- Participated in WCFA Executive Committee call.
- Working on the 2024 Annual Plan. Been waiting for final 2024 numbers.
- Conference call about Gile Flowage acquisition Land survey needs and identifying parcels to add or remove from the project.
- Gile title work is pending some survey work completion.
- NOAA funding falls under President Trump's Executive Order's review. DEI language in grant agreement.
- Larger issue with NOAA is potential staffing reductions as federal workforce reductions are occurring.
- ICF staff covered Courthouse maintenance and plowing while B. Nasi is on medical leave.
- Beginning work on the new Iron County Outdoor Recreation Plan.
